WHO

Project Unicorn is an effort of education non-profit InnovateEDU and 15 other leading education organizations to improve interoperability within K-12 education. More than 800 districts and 100 vendors have pledged to drive this movement forward in the last two years.

Lea(R)n is a public benefit corporation whose mission is to expand equitable access to education technology that works, enabled through its LearnPlatform comprehensive edtech management and rapid-cycle evaluation system which educators can use to organize, streamline and analyze their classroom technology.

WHAT

The Project Unicorn Product Library powered by LearnPlatform is a free hub for school leaders to identify, and for technology providers to register, interoperable education technology tools. Product providers can sign the Project Unicorn EdTech Vendor Pledge, and educators can identify the level of interoperability a vendor has reached, according to the Project Unicorn rubric. This Library is hosted on LearnPlatform and available through 1) a dedicated, curated digital index under the Project Unicorn name and 2) as a searchable product feature (i.e., badge) within the LearnPlatform community library accessible to anyone with a LearnPlatform license, including individuals creating a free account.

WHY

The partnership between Project Unicorn and Lea(R)n will drive market awareness and demand for high-quality learning technologies through support of enhanced interoperability, student data privacy and security, comprehensive edtech management, and informed decision making. We believe that more informed procurement choices which privilege privacy, security, and interoperability will enhance the ability of data to be used to drive instructional gains. The Project Unicorn Product Library powered by LearnPlatform will benefit both educators and vendors by highlighting commitment to interoperability and the FPF Student Privacy Pledge. By making these and other product attributes and commitments more transparent, educators will more easily use this information for better product selection and procurement.
